Cablevision commends the Department for its reasoned analysis in this matter and generally concurs with the recommendations and concerns raised in the written exceptions submitted by the New England Cable & Telecommunications Association, Inc. ("NECTA") in this proceeding. However, Comcast wishes to emphasize that any interconnection agreement between an incumbent cable television provider and AT&T must take into consideration the capital investment made by the incumbent cable provider to which AT&T will be a beneficiary.
